



CENTRALLY DUCTED HEAT PUMP & WEATHERIZATION REBATE

Including New Green Stimulus Bonus Rebates

Receive up to \$8,750 toward the installation of an eligible centrally ducted heat pump (CDHP) system. Total rebate will be capped at 75% of the installed cost. Additionally, pre-approved weatherization may be eligible for a 60% (owner-occupied) or 75% (rental) rebate. The Green Stimulus rebates are available until the end of 2020 and on a first-come-first served basis for installed projects.
