



COLD CLIMATE HEAT PUMP & WEATHERIZATION REBATE

Including New Green Stimulus Bonus Rebates

Receive up to \$3,350 toward the installation of an eligible cold climate heat pump (CCHP) system. Total rebate will be capped at 75% of the installed cost. Additionally, pre-approved weatherization may be eligible for a 60% (owner-occupied) or 75% (rental) rebate. The Green Stimulus rebates are available until the end of 2020 and on a first-come-first served basis for installed projects.
